REQUIRED CONTENTS OF APPLICATION PACKET:

- **Letter of reference from at least one current WAB member**
In order for full consideration, application must be accompanied by a letter of reference from a current WAB member. A directory of WAB members can be found on the WAB website at www.wyobuilds.com, or supplied to you through the WAB office.
- **Letter of intent, summarizing applicant services and relationship to building construction**
In order for full consideration, application must be accompanied by a letter of intent from applicant summarizing services (i.e. general contracting, residential plumbing) and the relationship services have to building construction (i.e. supply masonry products to building contractors).
- **WAB Membership Application**
Enclose this application as part of application packet.
- **Check for estimated dues**
A check for estimated dues must accompany application. In the event application is rejected, check will be returned to applicant.

I WILL BE CONSIDERED FOR MEMBERSHIP AS:

- WAB Membership consists of two types, Full Membership and Limited Membership, with several categories under each type. Select one type of membership, and one category under that type.

FULL MEMBERSHIP:

- A Full Member is eligible for all benefits offered by WAB, including, but not limited to health benefits. Full members have voting privileges and are eligible for representation on the WAB Board of Directors. Full membership categories are as follows:
 - **Supplier Member:** A person or business entity which provides materials and/or supplies to Contractors/Subcontractors involved in construction and building projects.
 - **Service Member:** A person or other legal entity which provides construction related services to Contractors/Subcontractors.
 - **Contractor Member:** An individual Wyoming resident or resident business entity which performs all or some aspects of building construction at project sites.

LIMITED MEMBERSHIP:

- A Limited Member is not eligible for WAB health benefits. Limited members have no voting privileges and are not eligible for representation on the WAB Board of Directors. Limited membership categories are as follows:
 - **Affiliate Member:** Any group or individual that prescribes to the principals of this Association, and is dedicated to furthering the objectives and purposes of the Association.
 - **Contributory Member:** Any group or individual makes a voluntary annual contribution to help defray the costs of furthering the objectives and purposes of the Association.

DUES

A check for estimated dues must accompany application. In the event application is rejected, check will be returned to applicant. Please write check for the dues appropriate to the category of membership you choose. Contractors select their dues from the chart provided. Make checks payable to WAB.
